Minutes of the Executive Meeting

Held in the premises of Oasis Retail Services, on Wednesday 13th June 2018

The Chairman, John Davidson, opened the meeting by inviting the Secretary, Harry Beckinsale, to read the minutes of the previous meeting, which were passed as a true record by Gerry Gallagher and Joe Patterson.

Gerry asked about our knowledge, if any, concerning the PSNI visiting clubs and public houses. The Chairman confirmed that information indicates that this is a task force process, which is unrelated to normal PSNI policing.

The Chairman continued to provide examples of issues which the PSNI appear to be objecting to.

The ensuing conversation included social media, which was correctly highlighted by Brian McCartney, as something which did not exist when the Clubs Order was structured. Nevertheless, a club can fall foul of the law through no fault of their own, due to unknowns innocently uploading information. If the information promotes activity in contravention of the clubs order, then of course, this can lead to difficulties.

Clubs are advised to, as far as is possible, avoid the use of social media.

One area which has presented problems is a club not having the required visitors book signed.

The Chairman spoke on behalf of the Executive Committee in congratulating the Federation Treasurer. David Larmour, on being awarded a BEM in Her Majesty the Queen's Birthday Honours list. The award is in recognition of David's service to boxing and his work in the community.

The Treasurer provided a detailed financial report, which was subsequently passed as a true record by Jim Hanna and Gerry Gallagher.

This was the final meeting before the summer break. although the helplines will undoubtedly continue to be busy in resolving issues.

The Secretary informed the committee of a recent award to Gillian Creevy, Chief Executive of the Cancer Fund for Children. The said award by CO3 was for 'Inspirational Leader of the Year'. The Chairman was delighted to learn of this, and will forward a letter of congratulations on behalf of the Federation's Executive Committee.

In closing, the Chairman thanked Oasis for hosting the meeting and for the excellent hospitality provided.

General Data Protection Regulation (GDPR) now in force

As you will have read in the last edition of Club Review, General Data Protection Regulation (GDPR) took effect from 25th May 2018.

This topic is causing much concern as compliance with GDPR requires a change in many policies and procedures and is not simply a tick box exercise; it needs all staff and volunteers to embrace new procedures.

To help you comply with GDPR, we advise the following to all clubs.

Information and guidance

Data protection legislation covers everyone about whom you keep personal data. This includes employees, volunteers, service users, members, supporters and donors. The legislation:

- requires organisations to register if they keep records (unless they are exempt and this includes most charities and clubs)
- governs the processing of personal data including 'personal sensitive
- requires organisations to comply with eight principles for data
- allows employees, service users and other contacts to request to see the personal data held on

Every organisation should have a written policy and procedure

that is specific to their context about how they handle personal data and enact privacy principles.

Support from the regulator

The Information Commissioner's Office (ICO) is the regulator for data protection and privacy law. Their website https://ico.org.uk/fororganisations/ is an excellent source of information and support and includes:

- their Guide to GDPR that they will regularly update and an FAQ page for charities
- specific pages for charities
- specific pages for small organisations
- an advice service by phone on 0303 123 1113 with a specific

service for small organisations (option 4) - you can also email casework@ico.org.uk

- a self-assessment toolkit for small and medium enterprises
- a code of practice for writing brivacy notices.
- an extensive index of specific guidance on a broad range of related topics like marketing, CCTV, data deletion, and filing
- advisory visits to your organisation for a day, with a short follow up report.

Of course, please feel free to contact the Federation Helplines and we will provide guidance where required.


BEM in Honours List

Gaming - why there's everything to play for

The introduction of new polymer banknotes, together with the new £1 coin, has been a technically and logistically difficult process for machine suppliers. Every note acceptor, coin mechanism and recycler has had to be reprogrammed several times to accept the new notes and £1 coin and to remove acceptance of the old paper notes and the round £1 coin.

Unfortunately, the technical specifications of the note were such, that the suppliers of the actual note acceptor units had to issue several complex software updates to ensure compatibility with machines produced by all the various manufacturers.

As a result, and despite everybody's best efforts, there has been an unprecedented number of 'note jams'. In addition, the £1 coin tolerances changed as they became more worn leading to increased coin rejection. All machine operators therefore saw a huge spike in the number of service calls attended due to note reader jams and coin acceptance issues.

Recently further new firmware has been released to the market which, once applied to machines, will see the number of note jams reduce to more normal levels. By now, all coin mechanisms should have been

updated to accept the new £1 coin to a consistent standard.

Machine incomes may have been adversely impacted earlier this year due to these problems but should now be returning to more normal levels.

The gaming machine industry has worked extremely hard to accommodate and deal with these major currency changes and has had to absorb all the costs of doing so with no financial assistance given by Government.

Be warned - fraudulent activity

There are organised criminals that specifically target gaming machines. This is more of an issue for pubs, as in clubs only members and their bona fide guests may use gaming machines. Clubs should nevertheless remain vigilant for unknown machine players attempting to access their machines.

They usually operate in groups of at least three people and typically work together to block sight of the machine whilst the theft is performed.

One person will tend to distract the bar or door staff whilst the theft is occurring and a club may not even be aware that they have been robbed until long after they have left the premises.

should ensure the machines are actively monitored; however, this will not necessarily deter thieves, as they will often

block the view to any camera recording their activities. The best way to deter thieves from attacking machines is by ensuring they cannot crowd

around them to block the view of staff and any CCTV.

machine to the bar does not necessarily deter them but active engagement from staff or members does. If in doubt, simply explain that only members and their bona fide guests are allowed to play the gaming machine, then ask that they play existing credits off and switch the machine off

until they have moved on. If the machine alarm sounds, this is a strong indicator that something is amiss and needs to be urgently investigated.

Also, clubs should always check suppliers ID badges before allowing anyone to collect, repair or remove a machine.

There have been further cases this year whereby thieves have walked into a club and said that the committee have organised a machine change. They have then 'removed' the old machine and simply driven off with it, complete with its contents.

If in doubt, always contact your machine supplier to check.

Questions & Answers

Q. We have a vacancy caused by the retirement of our Chairman and the Officers would like our Treasurer to take on this responsibility after the AGM. Would it be possible for this member to hold both positions?


A. There is nothing to prevent the Treasurer from standing for both offices, but as your club's



rules make clear, if a member is elected to more than one position, they must choose which office they wish to fill.

Therefore, should the Treasurer wish to stand for election to the office of Chairman at the AGM, and they are successful, then they will have to resign the position of Treasurer.

However, there is nothing to prevent the Treasurer from being appointed as the Chairman under the casual vacancies rule and for this position to be held jointly until the AGM. This would at least give the Treasurer an opportunity to see whether they find the role of Chairman comfortable and, indeed, whether the Committee think they are suitable.



Q. We are considering hiring an employee using a 'zero hours' contract although we are not sure if these contracts are still legal and if they are appropriate for use by a Club?

A. You are correct that there has been press coverage of these types of Contracts of Employment over the last few years. It is typically recognised by most people who engage in the debate over these types of contracts that they are useful to some industries, hospitality being one of those industries. The hospitality industry needs has wide seasonal trends and also frequent one off events such as parties. This means that many pubs and clubs will have some casual employees who can assist during busy periods. This type of employment can be of benefit to both employers and employees. It is accepted that many Clubs

will need to have additional assistance during special events, to cover established employees holiday time, assist with employee sickness absence and to provide greater bar coverage during peak times of the year such as Christmas. Zero hours contracts can be of use to employees, such as university students or employees with family commitments who like the flexibility that these contracts provide.

It is important to be aware that an employee on a zero hours contract does not have to accept any work that is offered to them. A typical Club will therefore have most of its employees on minimum guaranteed hours per week and may have a selection of casual employees who are willing to accept work as and when it is offered. Also remember, that just because an employee is contracted to do 20 hours per week, does not mean

that they will not be willing to work additional hours. You may find that you have sufficient flexibility in your current employees to cover additional hours as and when required.

It is important to note that employees on zero hours contracts are still entitled to the normal employment rights, notably that they will accrue holiday time for the hours which they work and that they must receive the minimum wage.

These types of contracts are unlikely to be banned in the future as most people accept that they can be useful for employers and employees in specific circumstances, the hospitality sector being the key example. It is, however, foreseeable that in the future, restrictions may be placed on these contracts to prevent exclusivity agreements being used (stopping an employee on a zero hours contract from working for another employee) and that a code of practice regarding fair use of this contract will have to be abided to by employers.

Q. In our Rules, a person has to have been a Member for at least one year before being eligible to stand for election to the Committee. Can you confirm if this still applies to Casual Vacancy appointments?

A. We can confirm that this time limit of one years' membership does not apply in the event of a casual vacancy appointment. Therefore, the Committee can appoint a Member to a casual vacancy even if they have been a Member for less than a year.







I recently had the pleasure of interviewing two of Ireland's finest Country singers on my Belfast 89FM show. James Lynas and Geri Kane, both of whom are proud to be natives of Belfast, are two artistes with heart-warming personalities, in addition to their vocal ability.

Geri recalled from her earliest memories, her love of music and singing, her debut as a singer at the age of eleven, appearing with Mr Tommy James on his popular UTV show, 'Tommy's Toy Shop', which provided a fee at that time of £11.

Whilst being educated at St Genevieve's School, Geri joined the school band, named 'The Ponchos', making their first live performance at the Grove Theatre, followed by appearances at several other venues, and appearances on the BBC programme 'Speak Easy'. Whilst in her mid teens, Geri entered a talent competition in Dublin's Drake Hotel, winning in the final, which provided a prize of a holiday for two in New York, and a cash prize of £1,000!

Geri is the proud owner of a telegram of congratulations, sent by the Bachelors, who won the same competition two years earlier!

After a few years Geri returned to Belfast to take up a career in nursing. However, showbusiness remained a major interest, leading to Geri joining the famed dance band 'Love Bug'. During her five years with 'Love Bug', the band recorded her hit single 'Father'.

A career break of two decades followed, during which time Geri raised her family, following which she returned to the music business, performing Country songs, which have always been where her heart lies.

Geri has enjoyed a successful recording career, touring the length and breadth of Ireland, with a recent tour of Scotland. and a new tour in England commencing shortly. This is a Lady who knows where she wants to be, and armed with the talent to get her there.

James Lynas, has been influenced by Country music from an early age, being inspired by such vocalists as George Strait, George Jones, Johnny Cash and others. He is also taking his band to the American Consulate in Belfast, following an invitation by the Ambassador to entertain his guests for the American Independence celebrations.


I have just been informed James has secured the No1 position in the Downtown Country chart. So it all appears to be happening for James, but be assured his feet remain firmly on the ground.

Akhwari shows real grit



John Stephen Akhwari hobbles into the Olympic Stadium in Mexico City to finish what he had started just under three and a half hours earlier.

After the marathon had already finished and the medal ceremony was completed, people were slowly leaving their seats and emptying the Olympic Stadium in Mexico City, when an announcement came over the tannov system. One last runner was about to make his way into the stadium.

Almost out of the cold darkness emerged a hobbling John Stephen Akhwari of Tanzania. With a bloody and bandaged leg, he completed the final lap as the remaining spectators cheered him on.

Although Akhwari had taken a bad fall much earlier in the race and knocked his head, got trampled on, cut and dislocated his knee, he picked himself up and started the long hobble home.


Having crossed the finish line, Akhwari collapsed into the arms of the medical personnel who then took him to hospital. When asked the next day why he didn't stop when he was injured, he famously answered, 'My country did not send me to Mexico City to start the race. They sent me to finish.'

John Stephen Akhwari had travelled more than 11,000km to race in the 1968 Mexico Olympic Games, and run the race he certainly did.

His steely determination and grit is an inspiration to many athletes.

Eusebio - the total gentleman

Manchester United had waited a long time for their chance to become kings of Europe. They'd even lost half their potential European Cup winning team in the terrible Munich air crash in 1958. And now ten years later. they were in the final, trying to win their first (and England's first) European Cup, against the great Benfica, who had the unstoppable goal-scoring genius Eusebio in their ranks.



It was the ultimate challenge for players, such as United's young talent, George Best. Other players,

like Bobby Charlton, who had survived the 1958 plane crash, were playing their hearts out for absent friends, team mates, town and country. The manager, Busby, who himself was given the last rites after the Munich crash, was there willing his team on; it was as if the world was willing Manchester United to win.

And then, in the closing stages of normal time, terror struck the hearts of Busby, Best, Charlton and the whole Manchester United side. Suddenly, out of nowhere, appeared Eusebio with the ball, clean through on his own, inside the penalty box, about to score. Eusebio shot from almost point blank range at the Manchester United goal - for what would have surely won the European Cup. Somehow, United's Alex Stepney saved the shot. Eusebio stood there, amazed at first and then he started to applaud Stepney. Eusebio even tried to put his arm around Stepney to congratulate him as the intense game continued.

Stepney didn't know what was going on and encouraged Eusebio to rejoin the game immediately. Eusebio jogged away while still clapping his hands towards Stepney. United went on to win in extra time but Eusebio's sporting approach to the game won the hearts of football fans around the world forever.

Football - Manchester City are crowned First Division champions, pipping their fierce rivals United, by only 2 points.

Snooker - England's John Pulman, defeated Australian, Eddie Charlton in the final of the World Championship by 39 frames to 34.
