Federation Update

Minutes of the Executive Meeting

Hosted by Philip Russell Limited, on Wednesday 9th January 2019

The Federation Executive Committee received a warm welcome to the offices of Philip Russell Limited, by Michael Barnes, General Manager, and Rhonda Simpson, Sales Manager.

Prior to commencing the meeting, the Chairman, John Davidson, thanked Philip Russell Ltd for inviting the Federation to their head office, and for the hospitality provided, following which he invited the Secretary, Harry Beckinsale, to read the minutes of the previous meeting, hosted by Diageo.

Correspondence was covered, with explanations provided. Included, was a particularly relevant case involving a club which was in dispute in part of its supply chain. With respect to both parties, it is not appropriate to provide innermost details, but needless to say the matter was resolved satisfactorily.

A number of calls have, and continued to be received on the MCPL license, which is for showing films. However, we agree with our associates in the UK, in that we object to this additional license. As registered, we are not public venues. Additionally, to our knowledge, they have not detailed which films they license. As stated previously, our counterparts

in the UK have made representation in respect to this license, in view of which we are happy for them to take the lead in this matter.

The Secretary provided details of a meeting with a supplier in the annual process of renewing trade associations.

The Secretary was pleased to confirm that, at the time of the meeting, our suppliers have reaffirmed their support of the Federation. Members should be aware that this allows us to maintain Federation membership fees at the same level since inception of the Federation, and of course to maintain our administration, helplines, and day-to-day activities on behalf of members.

A discussion took place on the number of clubs experiencing difficulty. Of course this is an ongoing matter of concern, and not helped by the suspended Assembly. We are aware that amendments to the Clubs Order, Accounts Regulations and other issues remain in limbo until such times that everyone is back in Stormont.

Employment legislation remains an issue for some, and often results in calls from club officials. Our employment guidelines remain unchanged, in that, in all cases, the first port of call should be the club insurers, which, if your club insurance is with Rollins Club Insurance, should be 'DAS'. Our Federation colleague Joe Patterson, who has experience in this field, is keen to underline this advice. He continues to emphasise that following procedure is of the utmost importance.

At this point the Treasurer, David Larmour, provided a financial report. He continued to provide an overview of membership renewals, the vast majority of which are now received by standing order. The report was passed as a true record by Tommy McMinn and Jim Hanna.

The next Executive Committee meeting will be hosted by the Felons Club, Belfast. Details of the Federation AGM, to be hosted by the RAOB Club In Belfast on Saturday 9th March 2019, will be included on the agenda, as will correspondence to club secretaries, together with Club Review.

At this point the Chairman closed the meeting, again expressing thanks to Philip Russell Ltd.

CORCA group meet at Westminster

The latest meeting of the All-Party Parliamentary Group for Non-Profit Making Members' Clubs (Clubs APPG) took place at the House of Commons on Tuesday, 4th December.

The meeting was chaired by Lord Smith of Hindhead

CBE, Joint Chairman of the Clubs APPG and the Chief Executive of the Association of Conservative Clubs (ACC) and in attendance on behalf of the CIU were: President, George Dawson CMD; Vice-President, John Tobin; General Secretary, Kenneth D. Green CMD; NEC Member, Les Hepworth CMD; CIU Legal Consultant, Allyn Walton; Gerry Sutcliffe (CIU Parliamentary Liaison) and Stephen Goulding (Head Office Manager).

On the agenda was a discussion of the Making Tax Digital initiative by HMRC which has the aim of making all businesses file their accounts online and whether some Members' Clubs would be exempt from the changes. It was agreed that the

Clubs APPG would send a letter to the appropriate Government department in order to seek clarification on any exemptions for clubs.

The next item on the agenda was the letters received by some clubs from the Motion Picture Licensing Company (MPLC) stating that they may need to purchase a licence if they broadcast anything other than sport, music or news on televisions in their clubs. It was agreed that the vast majority of Members' Clubs would have no need to purchase the licence and that a letter would be sent from the Clubs APPG to the MPLC to make them aware of any concerns held by the Clubs APPG's stakeholders.

The meeting then addressed the merger between the PPL and PRS For Music into one body whose purpose is to administer the licensing of music used in public. It was agreed that a letter clarifying the body's position regarding Members' Clubs would be sent to PPL PRS Ltd from the Clubs APPG.

Other topics discussed included: the continuing recruitment of more Members of Parliament and Members of the House of Lords to the Clubs APPG; current Government policy on gaming machines used in clubs and the variations in interpretations of the Licensing Act by Local Authorities.

The next meeting of the Clubs APPG will be set at a later date.

Staff problems?

Rollins Club Insurance can now provide wider cover!

The NIFC is always here to assist clubs with problems, and employment problems are one of the most common topics we are asked about.

Clubs should still continue to contact the NIFC with any such problems or questions which arise due to employment, but it is equally important to also consult with the club's insurers.

Currently, most club insurance policies include some form of employment cover, usually at very little extra cost to the policy. If you do not have insurance employment cover, you may want to raise this with your insurers, as it is an important addition.

The problem is, that whilst clubs may have this cover included in their policy, it usually has small print which states that the insurers should be contacted prior to disciplinary action being taken, even if this is simply inviting an employee to a meeting.

Insurers should definitely be contacted if an employee resigns or is dismissed. Clubs often only inform their insurers when a legal challenge is received and this is often too late. For the club to be covered by a typical insurance policy, the insurers want to be notified prior to any action being taken. They then require the club to follow their preferred procedure. If indeed

the club follows the required procedure, then it will usually receive free legal representation and also be covered for any costs or damages.

If you can establish that procedures have been provided by an independent professional HR advisor, then you may be able to recover this cost from your insurers.

For those insured under a DAS policy, with Rollins Club Insurance, it states: "The policy will pay legal costs up to £100,000, including solicitors' and barristers' fees, court costs, expenses for expert witnesses, attendance expenses, accountants' fees and employment compensation awards. It will also pay the costs of appealing or defending an appeal".

You can therefore understand the importance of informing the insurance provider at the earliest opportunity.

Dermot Rollins has informed us that the majority of their clients now enjoy wider cover, which provides for incidences where procedures may not have been followed correctly.

Details of the wider cover provided by Rollins Club Insurance (referred to above) will be outlined at the Federation AGM.

Preparing for an Annual General Meeting

An AGM is held to transact certain business: the report on the ballot for officers and committee (unless they are elected at the AGM itself); the report on the accounts; the adoption of the accounts, as audited; and other reports as required by a club's own rules.

Firstly, it is essential for the AGM to be properly summoned. This usually involves a notice being placed on the club notice board announcing the date and time of the meeting and requesting motions to be submitted to the Secretary by a certain date.

The rules of most clubs provide that a notice of the AGM shall be exhibited at least twentyone days before the date of the meeting; and the notice of any motion must be submitted within ten days following the posting of the notice. Rules can also say that the agenda must be posted for a specified number of days before the date of the meeting.

Before the meeting it is essential for whoever is taking the Chair - Club President or Chairman depending on the club's rules - to undertake a careful study of the agenda. This will mean he can conduct the business effectively and also spot any difficult matters that might arise. Preparation is crucial to the success of the meeting.

When the meeting starts, the Chairman should satisfy himself that the requisite quorum is

present. Most club rules require a quorum. This is to prevent a small, poorly attended meeting making decisions which affect the whole club.

The meeting must proceed with each item of business taken in the order in which it appears on the agenda. A normal agenda begins with confirmation of the minutes of the previous AGM, any business arising from them, then the Treasurer's report on the accounts, the election of officers, and so on.

The presiding officer, mindful of the need for a well-ordered, good tempered and constructive meeting, must see that the agenda is followed strictly. Speakers should stand when called by the chairman and, to

preserve order, only one person should be on their feet at the same time. When the Chairman rises any other speaker should sit down and this should be insisted upon. Unless this is done, a meeting can degenerate into disarray and chaos.

A proposal for discussion is a 'motion' and when it is accepted it becomes a 'resolution'. Before discussion begins, a motion must be proposed and seconded. A motion that is proposed, but finds no seconder, lapses and the meeting proceeds to next business. When a motion is proposed and seconded it is open for discussion. No speaker should be allowed to address the meeting more than once on each motion, except for the

proposer, who may reply to the debate. A motion may be ultra vires—that is, outside the scope of the meeting—and should immediately be ruled out of order by the chairman.

An amendment is a proposal to

alter the wording of a motion

and may be moved at any time

during the discussion of the original motion. Special care must be taken over this if the meeting is not to be allowed to become confused. The proposal requires a proposer and seconder before it can be considered by the meeting. The chairman should present an amendment to the meeting, once it has been properly proposed and seconded, in terms such as: 'To the motion before the meeting the following amendment has been duly proposed and seconded, that...' The wording of the amendment then follows and the immediate discussion must be confined to the subject of the amendment. Some bodies permit amendments to be moved to amendments but it is NOT recommended for clubs. If it is allowed it can prolong discussion and make for a complicated passage of business. In practice the proposer of the main amendment may incorporate in it what he considers best in suggestions for further amendments, if he accepts they will improve his proposal. No amendment may be a direct negative to the main motion for this would merely duplicate the need to vote on a particular proposition. An amendment must be disposed of before the meeting can proceed to a further amendment. If an amendment is accepted it becomes part of the original motion; it is then called the substantive motion. Further amendments may be considered in turn until all have been dealt with. Then, discussions may continue on

the substantive motion until it is put to the vote. Before the vote on each amendment the chairman should repeat its wording so that there is a clear understanding of the matter on which a vote is being taken.

Similarly the substantive motion should be read out again before the vote. When those 'for' and 'against' in each vote have been counted, the chairman should announce the result. If a large number of people are voting, the President should appoint two 'tellers' to count the votes. The tellers should both count the 'yes' and 'no' votes. If there is any disagreement the vote MUST be taken again. When an issue is controversial a close vote may be disputed so it is useful to be prepared for a written vote.

One further possible motion is `That this meeting do now adjourn.' This takes precedence over all other business and may be moved at any time during a meeting. The Chairman should not accept such a motion if he thinks it is being moved with the intention of disrupting the meeting. The decision is made on the vote of the meeting, on a motion proposed and seconded, and without lengthy discussion. Amendments are possible but only to set, limit or extend the period of the adjournment.

The correct conduct of a meeting is not an easy skill to master, but many difficulties can be avoided if the presiding officer follows the procedures set out here. However, even this will not guarantee that meetings are without problems. Some issues will so divide the membership that heated, and sometimes irresolvable, exchanges are inevitable. Nevertheless, a basic knowledge of tried, and accepted, procedures will help ensure that most meetings are managed efficiently.

Get to know your licences



Questions & Answers

Q. In advance of our AGM next month, we've been presented with a proposed rule change which requests that two members be allowed to sit in on Committee meetings as observers. I seem to recall quite clearly a piece you wrote in the magazine regarding the importance of confidentiality



tongues. Does the proposal have to go to the AGM, or can it be refused on the grounds of confidentiality beforehand?

A. I can confirm that a Rule change can only be voted upon and approved at a Special General Meeting. It cannot be discussed or voted on at an Annual General Meeting. Therefore, you can refuse this motion and direct this Member to call for a Special General Meeting if they wish for their rule change proposal to be discussed and voted on. A 75% majority of those Members present at an SGM is required to approve a rule change.

You are correct that it is important that Committee Meetings remain confidential and we would advise your Members not to vote for this

proposal if a Special General Meeting is ever convened to discuss and vote on it. Ultimately, it would be for the Club's Members to make the final decision on such a rule amendment although I hope they would appreciate that it would be difficult to ensure that Committee Meeting matters, such as employee information, is kept confidential if the

by non-Committee Members. In summary, you can prevent this from going to the AGM since it can only be dealt with at an SGM but ultimately, if an SGM was called and the change was approved by more than 75% of the Members present then it would be a valid rule amendment under those circumstances.

Committee Meeting is attended

Q. We have a member who has been proposed and seconded for election to the committee but due to a previously booked holiday he will not be able to attend the AGM. Will this prevent him from being elected onto the committee?

A. A member needs only to be proposed and seconded in order to be placed on the ballot for election to the committee.

Technically, once proposed and seconded a member does not need to be present at any point during the AGM, or the period leading up to the AGM, in order to be properly elected.

Unmissable Premier League lineup from Sky

Mirzapour, threw opposition aside and gifted Mexican goalkeeper,
Oswaldo Sanchez, with flowers and his condolences for the passing of Sanchez's father, who had died just days before.



Personal tragedy struck the Mexican goalkeeper Sanchez, during the 2006 World Cup Finals in Germany. His father, Felipe, died suddenly and most unexpectedly (from a heart attack) in Guadalajara on the Thursday. With the permission of his team, the sad Sanchez made the long and lonely journey across the world to bury his beloved father. Leaving behind the euphoria of playing in the World Cup Finals, Sanchez knew he might never play in another World Cup Match.

The team didn't know if he'd make it back for the game on the Sunday. He did. He buried his father and spent time grieving with his family before they insisted he get back on the plane and fly across the world in time to play in the game against Iran on the Sunday.

As is the tradition in big international football matches, after the national anthems, the players file past each other shaking hands. The two goalkeepers are usually at the end of the line. When the goalkeepers met, the Iranian keeper paused and bent down to pick up a bouquet of flowers which he gave to his opposite number, Sanchez the Mexican goalkeeper.

Although Mexico went on to win 3-1, the goal-keepers' moment transcended politics, power and even football results and demonstrated that from the brotherhood of sport, to the brotherhood of football, to the brotherhood of those unique people - goalkeepers, great sportsmanship prevails.

Teeing off in front of a big crowd can be a daunting experience, even for an experienced professional. Teeing off on the first day of golf's greatest competition, the Ryder Cup, has to be even more

When Northern Ireland's hugely talented, Darren Clarke, walked onto the first tee on the opening day of the Ryder Cup 2006 at the K Club, his opposite number, America's Phil Mickelson, walked towards him, held out his arms and embraced him in a warm bear hug. A magical sporting moment for the world to see.

The still grieving Clarke had lost his wife, Heather (39), to cancer only a month before and was probably a bag full of mixed emotions as he stepped up to the tee in the world's greatest golfing competition. The warmth and affection shown by his competitor helped to relax him and reassure him. Clarke hit a great shot.

In fact, Clarke went on to birdie his first hole and ultimately he and his partner Lee Westwood beat the Americans, Mickelson and DiMarco, on the first of three days of intense golf. Clarke held it together for his European golf team as they battled against the Americans during three days of highly competitive world class golf.

Mickelson's gesture helped Clarke to master his grief so that he could play his natural game - brilliant golf.
