Minutes of the Executive Meeting

Hosted by the H&W Welders F.S.C., Belfast, on Wednesday 10th April 2019

The Chairman, John Davidson, opened the meeting, following which he requested the Secretary, Harry Beckinsale, to read the minutes of the previous meeting, hosted by the Irish Republican Felons Club on 13th March 2019. The minutes were passed as a true record by Gerry Gallagher and Tommy McMinn.

Correspondence was covered, with explanations provided on such matters as PPL/PRS, and the MCPL License.

The Secretary referred one matter to the Chairman, who, together with Executive Committee colleague and HR advisor, Joe Patterson, will examine the detail. A brief response was initially provided to the club in question. The engagement of the club insurers was advised as the best course of action, always providing that this area (human resources) was provided in the club insurance policy. The benefit attached by the Rollins Club Insurance policy was again highlighted, as, of course, this is included in their club policy.

The Secretary mentioned that further cover can also be provided, to cover events where the club has not fully followed procedures. Obviously this carries an additional premium, but may be well worth considering, particularly where a member of the management team may have acted in variance to the said employment legislation procedure, or indeed, the club's own constitution.

Another issue was related to another member club in respect

to the re-election of officials, which appeared to be contrary to the club constitution. However, the Chairman was of the opinion that we did not have sufficient information on which to provide an accurate opinion, at this time. The Chairman asked that the Secretary relay this to the club in question.

Calls have continued to be received on the aforesaid MCPL license, with the same advice, which is presently to disregard correspondence received, as we continue to follow the guidance of CORCA. in UK.

Golf clubs continue to contact us in respect to the Sky TV tariff, with a number appearing to be unaware that a specific tariff has been available to golf clubs for some years. However it is intended to broach this subject in the interests of, not only golf clubs, but also in the interests of those clubs which do not enjoy the benefit of sport and recreational rating relief. We wish consideration to be afforded to establishing a tariff for those clubs, based on a given club's audited accounts.

With the Legislative Assembly remaining in suspension, frustration continues in respect to those amendments, which by now would have provided great benefit, to include amendments to the Clubs Order, Accounts Regulations and other issues such as advertising etc.

We have however been invited to contribute to the DSD Consultation to permit the sale of alcohol for Special Events.

The DSD Document has been provided to the chairman for his view on the matter.

A financial report was provided by the Treasurer, David Larmour. Membership renewals, in respect to clubs continuing to pay by cheque, was covered in respect to payments received, and those remaining unpaid. A little over seventy clubs pay by cheque. The Financial report was passed as a true record by Joe Patterson and Brian McCartney.

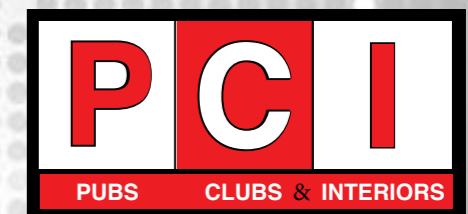
The Treasurer and Secretary continually communicate on the payment of membership fees. A number of clubs continue

What is the legal number of hours employees can have between shifts?

The legal number of hours between shifts is determined by the Working Time Regulations 1998 directive, subsequently amended by the Working Time (Amendment) Regulations (WTR) 2007 directive.

The Regulations specify requirements for:

- Night Work hours
- Daily and Weekly Rest periods
- Maximum Weekly Working Time
- Annual Leave

For Adult Workers (18+) there are 3 types of break - rest breaks at work, daily rest and weekly rest. The minimum rest period in a 24-hour period should not be less than 11 consecutive hours. In general, workers are entitled to at least 11 hours rest per day, at least one day off each week, and a rest break during the shift if it is longer than six hours. For an adult worker that minimum rest break is 20 minutes uninterrupted.

For Young Workers, the minimum rest period is 12 hours in any 24 hour period but rest may be interrupted by short duration work or periods of work being split up during the day.

Opt Out Agreement

An employer cannot insist that a worker works more than 48 hours per week on average. Any more than this is voluntary and subject to an Opt Out agreement.

For night workers, there is a maximum of 8 hours work in any 24 hours on average and a right to free health assessments.

Mobile workers are subject to a variation of these rules under the Road Transport WTR.

You can visit www.gov.uk/ maximum-weekly-working-hours for more information on the WTR and the rules for averaging out the above time limits over a period of time.

2019/20 financial update

National Minimum Wage / National Living Wage update

From 1st April 2019, employees in the UK aged over 25 earning the current minimum wage rate of £7.83 per hour will see a 38p increase to a minimum hourly rate of £8.21. Employees aged under 25 will also see an increase. The small details are set out below for you:

Current rates

- £7.83ph for ages 25+
- £7.3 8ph for ages 21 - 24
- £5.90ph for ages 18 - 20
- £4.20ph for school leaving age to 17
- £3.70ph for apprentices

New rates from 1st April 2019

- £8.21ph for ages 25+
- £7.70ph for ages 21 - 24

- £6.15ph for ages 18 - 20
- £4.35ph for school leaving age to 17
- £3.90ph for apprentices

Auto Enrolment Pension - April 2019 update

All clubs with eligible employees should now have enrolled into the Auto Enrolment Pension scheme. From 6th April 2019, the contributions from the employer and the employee will have increased. The club will now be contributing 3%, up from 2%, and the employee will contribute 5%, up from 3%.

Therefore, the overall total minimum contribution increases to 8% from its current rate of 5%.

Date	Employer Minimum	Employee Minimum	Total Minimum Contribution
Up to 5 April 2018	1%	1%	2%
6th April 2018 to 5 April 2019	2%	3%	5%
6 April 2019 onwards	3%	5%	8%

Further changes may occur from 2020, as the Department of Work and Pensions are considering all workers from the age of 18 being Auto Enrolled. At present only workers from age 22 are Auto Enrolled.

As an example, a member of staff earning £350 per week currently pays £5.62 (after tax relief) - the employer pays £4.68 totalling £10.30 per week into their pension pot. From the 6th April 2019, assuming that the member of staff has a 5% wage increase due to the change in National Living Wage the contributions would increase as follows.

On a new weekly rate £367.50, the employee's contribution would be £9.98 (after tax relief) and the employers would be £7.49 making a total of £17.47 per week into their pension pot.

Opt out rates

The impact on staff of pension contributions increases will be mitigated by the increase in the National Living Wage (NLW) and in the increase on the 6th April of the income tax personal

allowance from £11,850 to £12,500.

Research by The Pension Regulator shows less than 2% of staff in medium, small and micro businesses asked to leave their pension scheme as a result of the increases in 2018.

How will the living wage and pension increases affect the club?

The NLW and pension contribution increases will increase your payroll costs by just under 6%. Many committees have been debating by how much to increase bar prices as a result of supplier price rises but few consider the impact of the payroll increases.

It varies significantly from club to club but wage costs can represent up to 25% of bar takings; if no action is taken, and using this percentage, wage costs will increase to 26.5% of bar takings. In terms of bar prices, a club would need to add, with VAT, an extra 5p to a pint sold for £2.75, in addition to the brewery increases.



Protect club land with 'Keep-Off' signs

A recent case serves as a reminder to all clubs that club land must be protected from unauthorised persons using it. If unauthorised persons are allowed to consistently use club land then they may obtain a legal right to permanently use it. We advise that where open land exists, signs should be erected stating that the land is private and for use by club members only.

Court of Appeal judge, Lord Justice Richards, said that he "rejected the notion that it is necessary for the owner; having made his protest clear; to take further steps of confronting the wrongdoers orally or in writing, still less to go to the expense and trouble of legal proceedings.

"Many millions of people in this country own property. Most people do not seek confrontation, whether orally or in writing, and in many cases they may be concerned or even frightened of doing so. Most people do not have the means to bring legal proceedings. There is a social cost to confrontation and, unless absolutely necessary, the law of property should not require confrontation in

order for people to retain and defend what is theirs. The erection and maintenance of an appropriate sign is a peaceful and inexpensive means of making clear that property is private and not to be used by others. I do not see why those who choose to ignore such signs should thereby be entitled to obtain legal rights over the land."

The case revolved around land formerly owned by a private members club which had subsequently been acquired by new owners. Whilst the club was in operation, the next door fish and chip shop had consistently used the club's car park. When the building was sold, the owners of the fish and chip shop attempted to argue that the new owners had to respect their right to use the car park. There was no dispute that suppliers and customers of the fish and chip shop had used the car park since the shop opened in 1987, right up until access to the space was blocked by the new owners. However, they did so while ignoring signs that stated "Private Car Park, for the use of Club Patrons Only", which were displayed both on the side of the club building and in the window of the club.

Lord Justice Richards said that the presence of the signs was enough to make the use of the car park "contentious". The signs "clearly indicated the owner's continuing objection to unauthorised parking" and were a proportionate form of protest." The meaning of the signs was clear and persons other than club patrons would be aware that they were not authorised

to use the club's car park. The Court rejected that the club had to continually protest against the use of the car park by the fish and chip shop owners.

We therefore advise all clubs, which have land easily accessed by the public, to clearly display signs advising that the land is private and can only be used by club members and their guests.

Questions & Answers

Q. In advance of our AGM next month, we've been presented with a proposed rule change which requests that two members be allowed to sit in on Committee meetings as observers. I seem to recall quite clearly a piece you wrote in the magazine regarding the importance of confidentiality this appears to increase the

danger of loose tongues. Does the proposal have to go to the AGM, or can it be refused on the grounds of confidentiality beforehand?

A. I can confirm that a Rule change can only be voted upon and approved at a Special General Meeting. It cannot be discussed or voted on at an Annual General Meeting. Therefore, you can refuse this motion and direct this Member to call for a Special General Meeting if they wish for their rule change proposal to be discussed and voted on. A 75% majority of those Members present at an SGM is required to approve a rule change.

You are correct that it is important that Committee Meetings remain confidential and we would advise your



Members not to vote for this proposal if a Special General Meeting is ever convened to discuss and vote on it. Ultimately, it would be for the Club's Members to make the final decision on such a rule amendment although I hope they would appreciate that it would be difficult to ensure that Committee Meeting matters, such as employee information, is kept confidential if the Committee Meeting is attended by non-Committee Members.

In summary, you can prevent this from going to the AGM since it can only be dealt with at an SGM but ultimately, if an SGM was called and the change was approved by more than 75% of the Members present then it would be a valid rule amendment under those circumstances.

Q. We are aware that we can no longer charge for credit / debit card transactions but can we impose a minimum spend? Each transaction (we use Worldpay) costs us around £1.20 so it seems to me perfectly reasonable to require a minimum spend of £5.

A. We can confirm that you are Able to impose a minimum transaction purchase amount. Having said that, your card processing costs seem quite high, you might want to explore other providers to obtain a lower rate on your transactions. If you frequently process card transactions then your fees should be as low as 0.4% for debit cards and 1.1% for credit cards. You may want to contact Worldpay to see if you can renegotiate your contract.

Q. A Member has requested an AGM motion regarding a new subscription rate which decreases in line with the length of a Member's length of

Membership. The Committee are concerned that this would be difficult to administer and also could reduce the subscription revenue which is an important source of finance for the Club. The Committee would like to write to the Member explaining our concerns and hopefully the Member will withdraw their proposal. If the Member insists on putting his proposal to the AGM can the Committee prevent this?

A. I think such a reply would be sensible, although should the Member insist, then the motion should be placed on the agenda of the AGM to be voted on by the Members (the Committee can present your view to the Members at the meeting that such a proposal may not be in the long term interests of the Club). Most Clubs do already offer a wide variety of subscription packages, the most prevalent being Life Membership once a person has reached a specific age and has been a member of the Club for a set number of years or discounted subscription rates for couples. Having said that, some Clubs are moving towards a single membership fee applicable to all Members. This is really only a decision Clubs can make on a local level.

Ultimately, in most Clubs it is the Member's choice what to set the subscription rates at although I would hope they would be guided by the advice given to them by the Committee. It is worth noting that in some Clubs it is the Committee which has the power to directly set the subscription rates.

Living life to the full with Bryson Care

What is it about your club that brings members back every year?

Is it the sense of community?

The opportunity to meet up with like minded people?

The chance to share the enjoyment brought by a favourite sport or activity?

As the average age of our population ever increases, we are becoming more aware of the impact of social isolation and loneliness as we get older. In fact, Age UK reports that "the effect of isolation and loneliness can be as harmful to our health as smoking 15 cigarettes a day, and is more damaging than obesity" (www.ageuk.org.uk).

Isolation and loneliness often occurs when a spouse passes away or friends and relatives die or move away from the area, the person left behind suddenly has no-one to turn to, or perhaps only sees some friends or relatives on a few occasions.

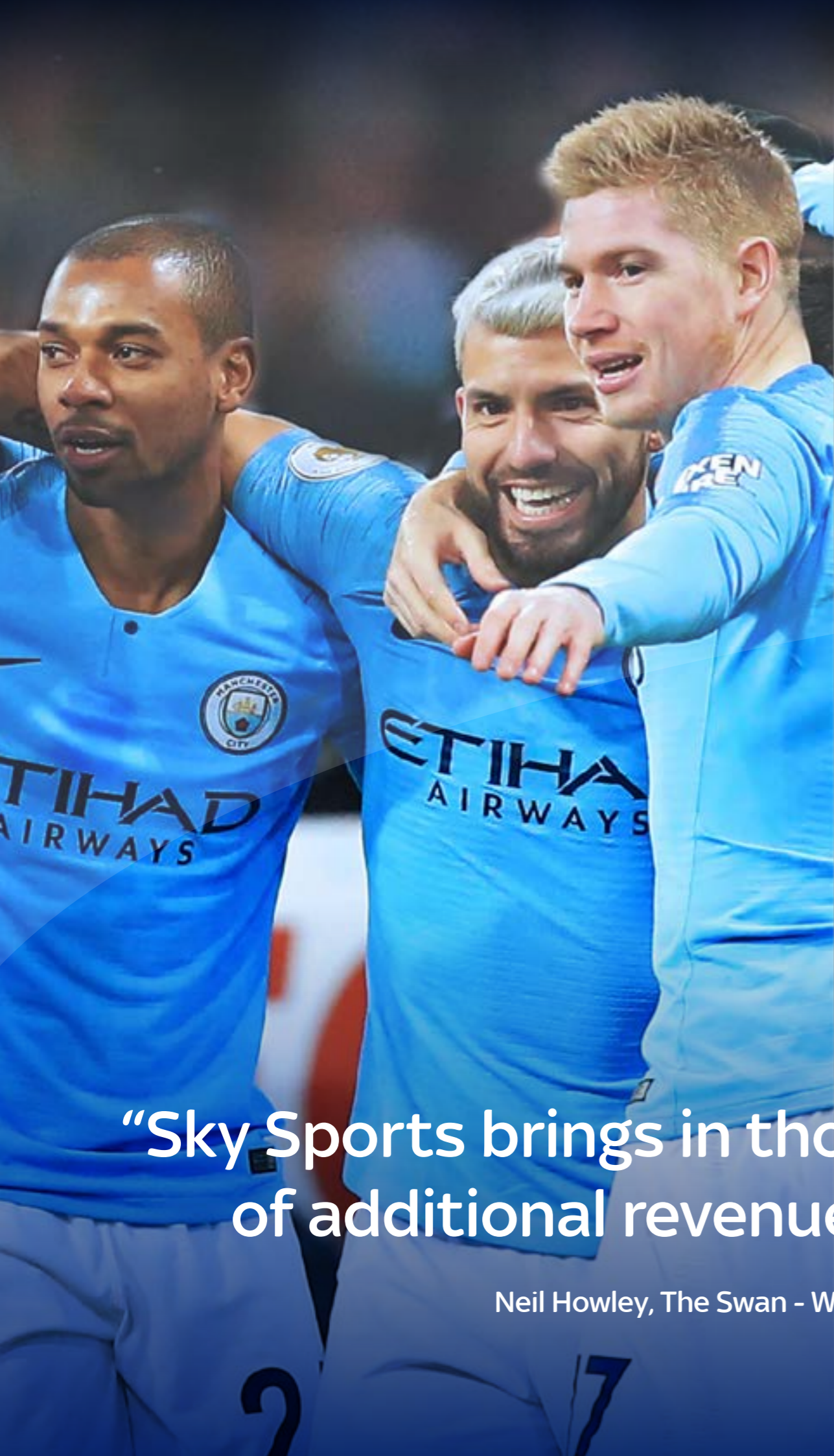

A bass man's life, and the 'Pound'!

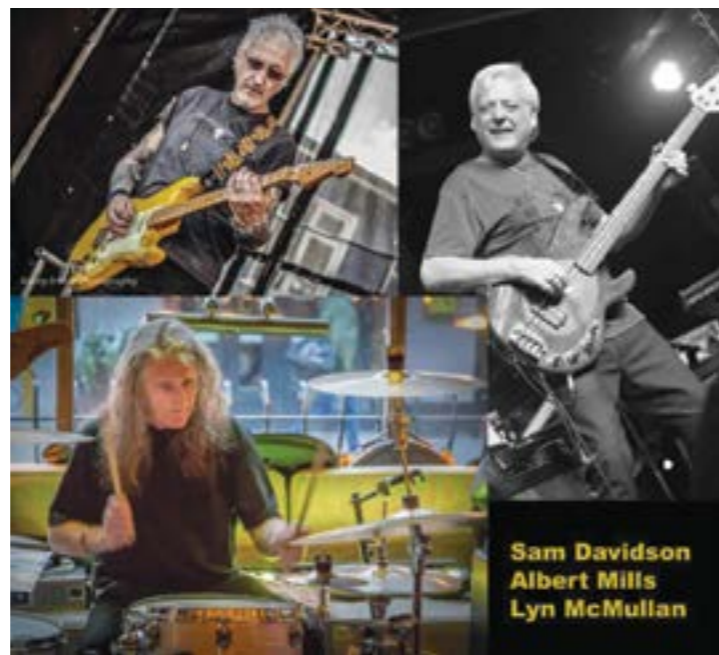

I recently interviewed Albert Mills, when he took me on his life's musical journey, and confessing to loving all types of music since an ealy age, since watching the Beatles..

He formed his first band, Generation X, who became Creative Minds, playing the likes of, Betty Staff's, the Floral Hall, and Dublin's 'Five Club'; and as a blues/rock band, supporting acts such as, Jethro Tull, Small Faces, and Fleetwood Mac.

During the darkest days of the troubles, Albert went to Liverpool for a brief period. Upon his return, he worked in the Belfast Rope Works., later moving with his family, to Antrim, when Albert took a position in British Enkalon, also joining local band, 'Long Street', and touring the cabaret circuit.



After a time he was offered a job with his long time friend, Bobby Dunseith, in Yellow Pages, along with Tommy Locke and Eddie McKee. Although a fantastic band, Albert's heart was not in the cabaret scene, and it was around.1976, that Bobby and Albert visited the 'Pound Club', where top rock and blues bands of the day, such as Spike, performed, fronted by incredible guitarist, Jim Armstrong.

While playing one evening at the Quarry Inn, Jim Armstrong approached Albert, offering him a position as bass player/vocalist with his new band 'Light'.

The following week they became the resident band in the Pound Club, appearing every Saturday afternoon, playing to packed audiences, both there, and in numerous venues across Ireland.

In 1978, Light recorded an album, with all but one song being original material. The

release of which all sold, and which is now keenly sought after.

Albert said, "I relive the memory of Light and the Pound Club each year, with a sell-out show at the Black Box, with a line-up which includes Ian 'speedo' Wilson, Brian Warnock, Brian Glen, Davy McClean and Joe Traynor.

Albert's musical journey continues with Sam Davidson's 'Taste', and 'Blackwood'. He counts himself lucky to be able to continue doing what he does, and to have made so many friends along the way, including the best of the best musicians on the rock and blues scene, too many to mention but suffice to say, he remains at the top of his game. So let me sign off by saying - 'Let there be LIGHT'.

Rory Beggan made history at the recent Ulster GAA Writers' Association annual awards presentation in Enniskillen, but the big Monaghan custodian wasn't there to enjoy the occasion. Instead, Beggan was training with the rest of the Farney fellows as they prepared for their closing NFL games which would decide their fate - staying in the top tier or a drop to Division Two. Training has since obviously produced results as Monaghan escaped the drop by a whisker.

Beggan was named as the first goalkeeper, in the 31 years' history of the UGAAWA accolades, to be awarded the Male Footballer of the Year and his father Brendan collected the award on his son's behalf.

However, Rory did send a video message to the assembled gathering, expressing his delight at getting the award.

In all, 13 annual awards were handed out with the Female Footballer of the Year crown going to Tyrone captain, Neamh Woods, who led the Red Hands to All-Ireland Intermediate Championship glory, netting a super goal in the final to polish off the opposition.

The UGAAWA annual awards are the only ones that cover the wide scope of GAA indoor and outdoor activities, with the likes of Culture and Services to the GAA included. The awards also cover players, officials, etc. from Young Achiever to Personality of the Year.

Slaughtneil Emmett's have, of course, created their own niche in camogie, and it can't be a surprise that the Derry

girls won the Team of the Year trophy as they sped through Ulster and then stopped Galway and Connacht title holders Ardahan by double scores.

The UGAAWA awards are not confined, of course, to senior successes and it was Glengormley St Enda's, who is the first Antrim team through to the All-Ireland Intermediate Football final, that took the Club of the Year title, having overcome many obstacles to climb amongst contenders for national glory.

It wasn't a great 2018 year in hurling for Ulster teams but, nevertheless, there were some excellent individual performances, none better than those by Antrim stalwart Neil McManus. The scorer-in-chief of the saffron side collected the Hurler of the Year honour for a third time, also being the winner in 2009 and 2011.

For the second season in a row, World One-Wall champion Conor McElduff (Tyrone) collected the Handball Award.

Titles also went to Monaghan, as Aaron Mulligan, who gave up a promising soccer career to concentrate on GAA, is the Young Achiever of the Year and Noel Duffy's communications work earned him that award.

Gaoth Dobháir beat a trail of success as they clinched the Ulster Club SFC title for the first time and nobody did more to achieve that than their long-servicing full-forward Kevin Cassidy. Kevin is one of the game's most colourful characters and for that he was honoured with the 2018 Personality of the Year crown.

As you filter through the gate into matches in Antrim and throughout Ulster you may know the face but not the name. It's Seamus O'Hare, who is one of the longest serving GAA volunteers in the province, and for his work he gets the Services to the GAA trophy, while another man, Armagh's Sean McCann, who is an avid Irish language worker, collected the Cultural Award.
